THE CG, III MAF HAS ASKED ME TO EXTEND HIS SINCERE APPRECIATION AND A "WELL DONE" FOR THE PROMPT AND FORTHRIGHT ACTION TAKEN BY MEMBERS OF YOUR COMMAND FOLLOWING THE LOSS OF CUA VIET TRANSSHIPMENT CAPABILITY DUE TO ENEMY ACTION ON 10 MAR 68.

I WISH TO ADD MY CONGRATULATIONS FOR THE PROFESSIONAL PERFORMANCE AND THE "CAN DO" ATTITUDE OF ALL CONCERNED. "LTGEN ROSSEN CG PCV".
